Hello all--

I want to thank everyone who has volunteered over the past year to assist in our community. Board members have helped behind the scenes, as well as in the trenches, to help get so many things completed. We have had a few residents come and help -- it is very much appreciated. We have been able to recently replant quite a few squares of sod, as well as planting some attractive shrubs at both entrances, plus the park entrance, to really jazz up our shared land. The community bulletin board at the park has been updated and looks great. We've been able to accomplish a lot in a short period of time. But, we do have more to complete.

The two biggest needs you will see outlined in this newsletter – the cleanliness of our lake and each of us following our community rules. For the lake, we will be working with the Pinellas County watershed management organization and researching what several contractors are offering, to help clean the algae and sediment out of it. We will then participate in a county program that will give us plants for free to beautify it.

For the community rules, we've seen some people have a "day off" from the rules, but also those who consistently disobey them. These community by-laws were provided to all residents and are available on our website. Once we live here, we must make the community better by abiding by these rules. If there is anything you do not agree with, please come to one of our monthly board meetings. We are just the enforcers – if you see a true issue with one of the rules, we can bring it to the community to be voted on and changed. This is OUR community, so let's continue to make it a great place to live

Community Improvements

The Lake

Our community is known and named for its **HIDDEN LAKE.** We have done very little to care for our lake over the years and it is starting to show. We have had a company spray for algae and what it has gotten us is a lake bottom layered with muck. The board has decided in the coming fiscal year(s) to research clean-up of our lake. As we find additional information, it will be passed along in future newsletters.

There are ways you, as residents of Hidden Lake, can help. Much of the street drainage flows into our lake and any debris including grass, leaves, pollen, fertilizer, etc. that enters the lake has organic materials that end up creating algae (just take a look at the lake and you will see the results). Please, do what you can to keep this kind of material from the street. Do not blow off any grass or leaves into the street.

Architectural Control

We want to remind all residence and especially new ones that when you are planning to make any changes to your home or major changes to your yard you are required to have the approval of the Board Of Directors before you commence.

On building issues even though you have County Approval with Permits you cannot proceed without the Board Of Directors approval; if you do you can be asked to remove what was done at your added expense. Your Board Of Directors, as appointed by the Community, has the responsibility and the obligation to keep Architectural Unity within the Community.

All residents should have a copy of our By Laws and Deed Restrictions. Please review to ensure that you follow the all requirements as a member of the Hidden Lake Homeowners Association. If you do not have a copy of the current By Laws and Deed Restrictions please contact the Board to obtain a copy. Let us all do what is right for our Community.

<u>Tailgate Thefts:</u> Since the middle of February, 3 tailgate thefts from pickup trucks have been reported to the Sheriff's Office from North Pinellas County. These thefts have occurred during the day and overnight. The trucks so far have been full size Fords between 2008-2016 model years. However, all modern pickup trucks feature easy to remove tailgates regardless of the make. Tailgate removal usually only requires the tailgate be opened about half way and the tailgate can simply be lifted off the hinges.

If your tailgate has a locking tailgate handle lock, I encourage you to use it. In addition, locks can be purchased to secure tailgates manufactured without a factory style lock. Especially if they have the backup camera built in. These go for a good price.
